Downloadable Content Licensing Agreement

Alexis Taylor Interiors, LLC (hereinafter, “Alexis Taylor Interiors,” “we,” “us,” “our”) is the creator, author, and copyright owner of Downloadable Content in the nature of Design Kits for bathrooms and other selected spaces within a home. We make certain of our Design Kits available to our valued customers in digital format, via internet download, for personal use, and to be applied to a single space within a single-family private home owned by the customer. This Downloadable Content Licensing Agreement (hereinafter, “Agreement”) becomes effective as soon as you (hereinafter, “customer,” “user,” “you,” “your”) initiate a transaction to pay for and/ or download (hereinafter, “transaction”) any one or more of our available Design Kits or other Downloadable Content, and you accept and agree to be legally bound by the terms of this Agreement as of that time.

This Agreement may be updated without notice.
